## **PRIVACY POLICY**

It's Umbrellapps Portal's Privacy Policy to respect your privacy regarding any information we collect from you across our website, https://umbrellapps.ovh, and other sites we own and operate.

## **ACCESS TO RESOURCES**

A part of Umbrellapps Portal resources are open and can be accessed directly requiring no registration, no login, no username, and no password. Umbrellapps Portal does not collect any user specific information about users accessing open resources.

Access to another part of resources marked with a padlock symbol is restricted and requires login. Users can login as guests or register their own login credentials.

#### **SECURITY AND PASSWORDS**

- Passwords are stored and encrypted in an irreversible format in our database. We allow users to change their password at any time
- You are responsible for safeguarding the password that you use to access the Portal and for any activities or actions under your password, whether your password is with our Portal or a third-party service.

## OPTIONAL PERSONAL INFORMATION COLLECTION

- Optionally we may ask for personal information, such as your anonymous email address, this information will consist an additional layer of account security. It will be used to send user changes confirmation/validation, send newsletters or to contact users. All information that we may request are asked to improve the Portal. We will never share / sell user emails, passwords or any personal information to anyone.
- While interacting with the portal you have to make sure that none of information provided by you enables to identify you. If the provided information such as username or email enable to identify you by the first and last name, the portal will immediately close such an account and delete all associated data.

# **NEWSLETTER**

- By creating an account including an email you agree to receive a newsletter which will contain the most important information and will be sent up to 4 times per year. You can stop receiving the newsletter by deleting your account.

# CATEGORIES OF DATA PROCESSED

- Date and time of registration/login, email address. The collection of the user's email address serves to deliver the newsletter. The collection of other Personal Data as part of the registration process serves to prevent misuse of the Portal, for example to create multiple accounts.
- We currently don't collect IP addresses. However, in future we may collect IP addresses to further improve our services.

#### COOKIES

- We currently don't use cookies. However, in future we may use cookies to further improve our services and to collect information about users activity across our site.
- Cookies allows to store a small data on user's browser about visits to a site. Any information collected will not have any identifying data. It's statistical data about our visitors and how they use our site. No personal details will be shared that could identify you. By means of these cookies, we collect information about your website visits in order to create anonymous evaluations and statistics about the use of our website.
- You can restrict or completely prevent the storage of (certain) cookies and bots via your browser settings. For more detailed information, please refer to the instructions or help function of your

browser. In principle, our website can still be visited and used after cookies have been restricted/deactivated in the browser settings. Please note, however, some of your features will not be available if you instruct your browser to refuse cookies.
